POLICIES FOR PHOTOGRAPHY AT LAURELWOOD ARBORETUM

Visitors are welcome to take photographs at Laurelwood Arboretum for their own personal use and enjoyment. Permits are required for any Professional Photography, Professional Wedding Photography and Commercial Photography. The following policies apply to all persons taking still or moving images on the grounds of Laurelwood Arboretum.

- We ask that photographers help preserve this special place by leaving the Arboretum as it was found. Please take all items that have been brought into the Arboretum with you when leaving, including trash.
- Please stay on the pathways and do not tread or place any objects in the gardens, streams or ponds.
- Please do not tamper with any Arboretum property, including trees, plants, signs and structures.
- The Arboretum is a public park and we have many visitors. Please do not interfere with their enjoyment of the grounds. We would also appreciate photographers allowing staff and volunteers to do their jobs in the Arboretum without interference, and following any instructions given by them. We encourage respect and courtesy among all users of the Arboretum.
- All guests must park in designated parking lots. No unauthorized motor vehicles are permitted on the Arboretum's roadways. Arrangements may be made for the use of a motorized cart operated by a Laurelwood Arboretum volunteer or employee in advance of any photography shoot.
- The use of unmanned aerial vehicles or drones is not allowed in the Arboretum.
- Smoking, alcoholic beverages, illegal drugs and ballplaying are prohibited on the premises.
- Please note that photographs of Laurelwood Arboretum are not permitted to be used in any manner that implies an endorsement of any product, person, enterprise or opinion.
- The Laurelwood Office Manager must be notified of a cancellation of Wedding Photography, Other Single Shoot Photography, or Commercial Photography at least one (1) week in advance. Refunds will be made only upon receipt of written Cancellation
- If the Wedding Photography, Other Single Shoot Photography, or Commercial Photography has been rained out and a rescheduling is desired, the original application should be resubmitted with an alternate date indicated. If rescheduling is not desired, a full refund will be made.
